Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per sub-section (1) of section 24 of the Kerala Labour Welfare Fund Act, 1975 (II of 1977) the Government may, by notification in the Gazette, appoint such person as they think fit and possessing such qualifications as may be prescribed, to be Inspectors for the purpose of the Act and may define the local limits within which, and the class of establishments in respect of which, they shall exercise their functions. The local limits of Labour Welfare Fund Inspectors was defined and published lastly in 1996. Now Inspectors were appointed in the Kerala Labour Welfare Fund Board through the Kerala Public Service Commission. The Labour Welfare Fund Commissioner has requested the Government to publish the appointment and the local limits of Labour Welfare Fund Inspectors in the Kerala Gazette as per section 24 of the Labour Welfare Fund Act, 1975. Government have examined the matter in detail and have decided to publish the appointment and the local limits of jurisdiction of the Labour Welfare Fund Inspectors as required under section 24 of the Labour Welfare Fund Act, 1975.

The notification is intended to achieve the above object.
